

**CALUMET CHRISTIAN SCHOOL
2017/2018 FINANCIAL INFORMATION & AGREEMENT**

Testing Fee: \$25 per student (non-refundable)
Registration: \$200 per student (non-refundable)

The fee as well as all paperwork must be turned in to be considered officially enrolled.

A 5% discount is offered if tuition is paid in full by August 1, 2017.

A 2% discount is offered if tuition is paid in full at the beginning of each semester.
(August 1, 2017 and January 1, 2018)

Voucher Requirements: A copy of your 1040 tax form for 2016 must be included with your registration paperwork along with the enclosed voucher forms required by the State of Indiana. The registration fee and tuition amount will be submitted to the Indiana Choice Scholarship Program. Once the state has determined the amount of your child's scholarship award, we will notify you of any remaining balance which will be due from you. If necessary, we will set up a monthly payment plan for your convenience.

If more students with vouchers apply than there are student voucher openings, there will be a public lottery held at the school to determine who will be accepted into our school. Some classes may already be closed due to current student enrollment.

Elementary Fees:

- Credit Account Fee: A \$100 fee per family will be charged with the August 1st tuition statement to begin funding a "Credit Account" for your family. Charges for classroom supplies, field trips, milk, etc. will be deducted from this account. As your "credit account" is depleted, you will be asked to "restock" the account. If this fund is not used up at the end of the year, you will be refunded its remaining balance.
- MILK: Milk will be available each day for a cost of \$.35. Order forms will be sent home once a month. These charges will be deducted from your "Credit Account" as described above.
- Early Care: Early care will be provided from 7:00 - 7:45 a.m. at a charge of \$3.00 per child per day. Students will not be allowed into the building before that time. Any students who arrive before 7:45 a.m. will be assigned to early care and will be charged the \$3.00 rate. **Elementary school officially begins at 8:00 a.m.** You will be billed weekly for early care.
- After Care: Aftercare will be provided from 3:15 - 5:15 p.m. at a charge of \$3.00 per child per hour regardless of how much of the hour is used. Students must be picked up no later than 5:15 p.m. After that time, each child will be charged \$5.00 per 15 minutes. You will be billed weekly for aftercare.

Middle / High School Fees:

- Sports fees will be charged for all participating students due to the high cost of the Athletic Program.

FINANCIAL POLICY: All payments are due on the first of each month. This includes tuition and any other charges or fees. Payments begin August 1, 2017, and end May 1, 2018. After the 5th of the month, a \$20.00 late charge will be added to the account. If tuition and other charges are still outstanding on the 15th of the month, your student(s) will not be allowed to attend classes the following school day until the account is up-to-date. **THIS FINANCIAL POLICY WILL BE STRICTLY ENFORCED.**

1. There is a \$20.00 returned check fee for "NSF checks". After two NSF checks, we can only accept cash as payment for the remainder of the school year.
2. All accounts must be up-to-date at the time of registration and kept up-to-date in order for students to remain in class. A student is not considered officially registered for school any time his/her account is in arrears.
3. **End of the School Year: Report cards and school records will be held until the outstanding account has been paid in full.**
4. **Refunds: All fees are non-refundable.**
5. All registration fees and paperwork are due with this form.
